INFORMATION CLAUSE

According to Art. 13 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (Journal of Laws UE L 119/1 of May 4, 2016), hereinafter referred to as "GDPR", the Institute of Legal Sciences of the Polish Academy of Sciences informs that:

1. Administrator of personal data:

2. Inspector of personal data protection

3. The aims of data processing and its legal basis

The Institute will process your personal data to carry out the recruitment procedure in the FRICoRe project.

The legal basis for the processing of your personal data is the announcement of the recruitment of contractors in the FRICoRe project, in conjunction with the generally applicable provisions on the protection of personal data and internal regulations of the Institute of Legal Sciences of the Polish Academy of Sciences specifying the manner of collecting and protecting personal data.

4. The period of processing of personal data

We will process your personal data for the period of: two months from the end of the application process in the recruitment procedure.

5. The data recipients

The Institute will transfer your personal data to entities commissioned to perform activities that may involve the processing of personal data (including IT service providers to whom we commission services related to the processing of personal data).

6. The obligation to transfer data

The necessity to provide personal data results from the necessity to undertake activities related to the selection of a contractor in the FRICoRe project and the signing of a cooperation agreement under the project.

The consequence of not providing your personal data will be the inability to participate in the recruitment procedure.

7. Your rights concerning personal data processing

You have the following rights related to the processing of personal data:

- a) the right to access your personal data information on the processing of personal data and copies of your data,
- b) the right to request the rectification of your personal data,
- c) the right to request the deletion of your personal data,
- d) the right to request the restriction of the processing of your personal data,
- e) the right to object to the processing of your data due to your special situation in cases where we process your data in the scope of a task carried out in the public interest,
- f) the right to transfer your data / due to the fact that the premise for the processing of your personal data is not consent, you do not have the right to transfer data.

8. Information on automated decision-making and on profiling

The Institute of Legal Sciences of the Polish Academy of Sciences does not use your data for automated decision-making and does not perform profiling.

9. The right to lodge a complaint to a supervisory body

You also have the right to lodge a complaint with the supervisory body that deals with the protection of personal data, i.e. the President of the Office for Personal Data Protection, if you believe that the provisions of the GDPR have been violated.
